This waiver is on behalf of myself, my heirs, my executors, administrators and assigns. I understand that this agreement specifically includes the use of any motor vehicle either personal or borrowed either on or off Air Show premises and that I am taking personal responsibility for any vehicle that I operate.

It is understood and agreed that all rights under the statute which provides as follows, "Certain Claims Not Affected by General Release - A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor," are hereby expressly waived.

Fully understanding that air shows are activities that include situations that pose a danger to me and my personal property, I hereby acknowledge and assume all risk of injuries or damage to my person or property. No promise or inducement, which is not herein expressed has been made to me, and in executing this Release I do not rely upon any statement or representation made by any person or their agent.

### Airport Operation Area (AOA), Statement

#### Terms of Admittance to the Airport Operation Area (AOA), of the Charlotte County Airport:

All vehicles, equipment, containers, bags, luggage and persons entering the AOA of the Charlotte County Airport are subject to security check and search, partially and fully, solely at the discretion of the Transportation and Security Administration, Office of Homeland Security and/or any of the following authorities: Charlotte County Sheriff's Department; Punta Gorda Police Department; Florida Highway Patrol; Florida Department of Law Enforcement; Charlotte County Airport Authority or the Florida International Air Show, or any designee of those authorities.

Acceptance of admittance and/or signing of a contract with FIAS constitutes full acceptance of these terms. Entry to the AOA prior to noon, Friday before the Air Show will be by escort only.
